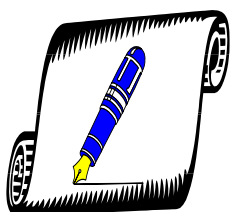

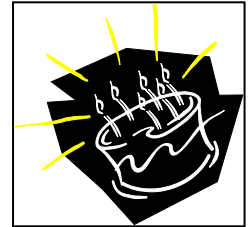
**MEET OUR NEW PRESIDENT**
